Limited Bestway Warranty Statement

Bestway, Inc. ("Bestway") warrants each new RetrieverTM SLT product to be free from defects in manufactured components and workmanship. This warranty is applicable for a period of twelve (12) consecutive months from date of delivery of the new RetrieverTM SLT product to the original purchaser.

Purchased components, excluding Honda engine, installed by Bestway, Inc. (hydraulic pump, control valve, relief valves, cylinders, hoses, fittings, etc.) shall be warranted by their respective manufacturer for a period of twelve (12) consecutive months from date of delivery of the new RetrieverTM SLT product to the original purchaser.

Each RetrieverTM SLT Honda engine shall be warranted by Honda for a period of thirty-six (36) consecutive months from date of delivery of the new RetrieverTM SLT product to the original purchaser. Honda Limited Warranty supersedes any and all Bestway, Inc. supplied warranty pertaining to the RetrieverTM SLT Honda engine. Note: Please see Honda Limited Warranty policy for additional information.

A completed RetrieverTM SLT Owner Registration Form from the original purchaser must be received by Bestway, Inc. to activate warranty coverage. Failure to do so may void any and all RetrieverTM SLT product warranty to include Honda engine warranty.

The above warranties DO NOT cover:

- system fluids, disposal or replacement, product towing, telephone use, travel expenses, cleaning cost, or chemical disposal or replacement;
- failures contributed to conducting preventative maintenance on product;
- paint or paint related cosmetic issues and/or decals other then safety decals;
- tires and wheels due to irregular wear, deflation, maintenance or overload

The above warranties DO NOT apply under the following conditions:

- when product is used for purposes for which it was not originally designed or intended;
- when product is under abnormal operating conditions or use exceeds product parameters;

Genuine RetrieverTM SLT replacement parts and components shall be warranted for a period of ninety (90) days from date of purchase, or the remainder of the original equipment warranty period, whichever is longer.

Under no circumstances will Bestway, Inc. warrant any merchandise or components thereof, which, in the opinion of Bestway, Inc., has been subjected to misuse, unauthorized modifications, alteration, an accident, striking on obstruction (whether ground or object), or if repairs have been made with parts other than those obtainable through Bestway, Inc.

Bestway, Inc. obligation under this warranty shall be limited to repairing or replacing, free of charge to the original purchaser, any part that, in Bestway, Inc. judgment, shall show evidence of such defect, provided further that such part shall be returned within thirty (30) days from date of failure to Bestway, Inc. – Hiawatha, Kansas. All transportation charges must be prepaid. Limited labor coverage, less labor paid for diagnosis, extends to any repair made under normal warranty coverage by authorized persons set forth by Bestway, Inc. Unauthorized repair without Bestway, Inc. knowledge may void warranty coverage.

This warranty shall not be interpreted to render Bestway, Inc. liable for injury or damages of any kind or nature to person or property. This warranty does not extend to the loss for labor, substitute machinery, rental equipment, damage to equipment being loaded or transported, or for any other reason not covered under the above warranties.

Except as set forth, Bestway, Inc. shall have no obligation or liability of any kind on account of its equipment and shall not be liable for special or consequential damages.

Bestway, Inc. makes no other warranty, expressed or implied, and, specifically, Bestway, Inc. disclaims any implied warranty or merchantability or fitness for a particular purpose. Some states or provinces do not permit limitations or exclusions of implied warranties or incidental or consequential damages, so the limitations or exclusions in this warranty may not apply.

This warranty is subject to any existing conditions of supply, which may directly affect Bestway, Inc. ability to obtain materials or manufacture replacement parts.

Bestway, Inc. reserves the right to make improvements in design or changes in specifications at any time, without incurring any obligation to owners of units previously sold.

No one is authorized to alter, modify or enlarge this warranty nor the exclusions, limitations and reservations.
